

## COWES TOWN COUNCIL

Minutes of the Meeting of the FINANCE COMMITTEE held at the Community Hall, Northwood House, Cowes on Wednesday, 12<sup>th</sup> July, 2010 at 6.00 p.m.

### 327 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors McGregor and Peacey-Wilcox.

### 328 MINUTES

#### RESOLVED

That the Minutes of the Meeting held on 26<sup>th</sup> May, 2010 be taken as read, approved as a correct record and signed by the Chairman.

### 329 FINANCIAL STATEMENT

The Town Clerk submitted a Financial Statement giving details of income and expenditure against budget for the period to 12<sup>th</sup> July, 2010. He also submitted details of the balances on all of the Town Council's accounts as at 12<sup>th</sup> July, 2010 totalling £174,501; deducting the anticipated further expenditure to year end and the £74,805 expenditure that the Town Council had 'ring fenced' should leave a useable year end balance of approximately £40,000.

### 330 APPLICATION FOR FINANCIAL ASSISTANCE FOR SPECIAL EVENT

The Town Clerk submitted a letter from Cowes Week Ltd. together with a draft budget for the 2010 Cowes Week fireworks; a benefactor would provide the cost of the fireworks so they were seeking financial assistance towards the £21,400 needed for the display infrastructure. Cowes Week Ltd. had set up a designated bank account for the fireworks and to date had received pledges or donations totalling £15 to £16k towards the required total.

#### RECOMMENDED

1). That subject to receipt of income and expenditure accounts for the 2009 fireworks the Town Council makes a donation of £1,000 towards the 2010 firework display with an agreement to underwrite up to a further £1,000 should there be any eventual shortfall of funding.

(Councillor Banks declared a personal and prejudicial interest in the above as he was a member of Cowes Week Ltd. Shoreside Committee and he left the room for this item).

### 331 APPLICATIONS FOR GRANTS

Members of the Finance Committee had received copies of all applications for grants including copies of the relevant accounts; the sum of £4,540 remained unallocated in the budget to enable small grants to be made to local organisations.

#### a). Cowes Royal British Legion Band.

Towards the upkeep of their uniforms and the costs associated with representing the town in Deauville.

#### b). Cowes Town Regatta Committee.

Towards Challenge trophies for 2 new classes of event and keeper prizes to local classes.

#### c). Association of Sail Training Organisations.

Assistance with the costs of the 2010 ASTO sailing event that is held for disadvantaged and disabled youngsters.

#### d). Victim Support.

Funding towards the recruitment, training and support of volunteers to work with local residents.

## **RECOMMENDED**

1). That grants be made to the following organisations in accordance with the amounts shown:

(Councillor Banks declared a personal and prejudicial interest in a) above as he was Vice President of the band and Councillor Sanderson in b) above as he was a member of the Cowes Town Regatta Committee; they left the room for these items)

2). That subject to receipt of income and expenditure accounts for the 2009 ASTO event the Town Council makes a donation of £500 towards the 2010 event;

(Councillor Wells declared a personal and prejudicial interest in c) above as he was a member of the ASTO committee and he left the room for this item)

3). That no grant be made in respect of the application from Victim Support; and

4). That the balance of £3,340 in the estimates be kept in reserve pending further applications which may be received.

### **332 AFFILIATION FEE – I.W. PLAYING FIELDS ASSOCIATION**

The Town Clerk reported that the I.W. Playing Fields Association, which after a number of years of inactivity had been resurrected to an active association, were requesting all Town and Parish Council pay an annual affiliation fee of £25.

#### **RECOMMENDED**

That the Town Council pays an annual affiliation fee of £25 to the I,W, Playing Fields Association (Councillor Walters declared a personal and prejudicial interest as he was the Treasurer of the Association and he left the room for this item).

### **333 REMEMBRANCE DAY**

The Cowes Branch of the Royal British Legion had requested a donation to enable them to provide refreshments for those taking part in the Remembrance Day Service and Parade on 14<sup>th</sup> November, 2010.

#### **RECOMMENDED**

That the Town Council contributes £200 to the Cowes Branch of the Royal British Legion to assist with the cost of refreshments for those taking part in the 2010 Remembrance Day Parade.
