 - P/00475/12 Demolition of conservatory; proposed alterations and two storey side and rear extension to form additional living accommodation; single storey rear extension to form a conservatory, 27 Ward Avenue
 - P/00514/12 Demolition of w.c. at ground floor level and removal of rear access tunnel; alterations; two storey extension at rear level to provide additional living accommodation; proposed porch and bin store on front elevation, 42 Fellows Road
 - P/00465/12 Retention of summerhouse, workshop and store with decking, 99 Park Road
 - P/00557/12 Provision of window and french doors with juliet balcony on east elevation, 5 Raleigh House, Medina Gardens, Denmark Road
