a) Street Furniture Application - That Shop, 38 High Street

Councillors discussed this street furniture applications and it was:

b) Street Furniture Permits - Conditions

Cowes Town Council have recently been considering street furniture applications for seating areas outside of premises in Cowes High Street. In response to the applications, Cowes Town Council asked the IW Council when considering these applications, from a safety point of view, that any movable barriers around the seating areas should be secured in place by fixed sockets so that tables and chairs cannot encroach further than the permitted area agreed.

The IW Council have responded by stating that it is a condition of their permit that barriers are not secured to the highway: Condition No. 8 – "The permit holder shall not in any way interfere with the surface of the public highway". However, they state that the areas will be monitored to ensure that tables and chairs do not encroach further than the permitted area.
