691 APOLOGIES FOR ABSENCE

692 MINUTES

RESOLVED

693 DECLARATIONS OF INTEREST

There were no declarations of interest at this stage.

694 PLANNING APPLICATIONS

Councillor Jones submitted details of the planning applications received and following the Committees consideration of each application it was:

RESOLVED

- 1). That the Town Council supports the following applications:
 - P/00949/13 Demolition of building; proposed pair of semi-detached dwellings, 225 Arctic Road
 - P/01147/13 Replacement of planning permission (P/01182/09 TCP/29232/A: demolition of garage; alterations; 2 storey extensions to side, front and rear elevations to provide additional living accommodation; porch; terrace/balcony with balustrading on rear elevation; external staircase (revised scheme)(revised plans)) in order to extend the time limit for implementation, 10 Lammas Close
 - P/01200/13 Demolition of utility; proposed single storey rear extensions to provide dining room and replacement utility, 21 Parklands Avenue
 - P/01127/13 LBC for replacement of window with new doorway at first floor level on south elevation, Claremont House, Market Hill
 - P/01216/13 Continued use of rear unit as marine associated retail (Class A1), 124 High Street
- 2). That the Town Council objects to application P/01160/13 for roof gallery and terrace to nos: 23, 27 and 29; proposed balustrading on front and rear elevations at roof level to no: 25 (revised scheme), 23, 25, 27 and 29, Cliff Road on the grounds that the proposal lacks visual continuity, that it is aesthetically out of character with the surrounding area, that it is over dominant and because it would set an unacceptable precedent; and
